- Dealer may submit multiple registration forms with corresponding sales documentation, but will receive no more than \$1,500/truck, up to 4 trucks (\$6,000 maximum per dealer location)

- All completed rebate forms and supporting documents must be received by December 31, 2023
- TAX ID AND SALES INVOICE ARE REQUIRED TO RECEIVE REBATE. All other forms of documentation will be denied
- Sales invoice must show date of purchase, product description, and purchase price

To qualify as a repurchase, the dealer must have purchased at least one truckload of ExpertFinish products in 2019/2020/2021/2022. Each rebate offer shall be subject to review and approval by LP and shall be subject to the terms and conditions of the rebate. This rebate applies only to product purchased between January 1, 2023 and December 31, 2023. Rebate is limited to 4 trucks per dealer location (\$6,000 max). This rebate is NOT available to distributors, buying groups, builders, contractors, or homeowners. Rebate checks will be issued to eligible dealers based upon the verifiable information provided on the registration form. Invoice must show date of purchase, product description, and purchase price.
