

**"Show Us Your LP® SmartSide®!"  
Official Contest Rules**

***By entering the Contest, you accept and agree to be bound by these Official Contest Rules.***

**1. Sponsor:** The "Show Us Your LP® SmartSide®!" Contest (the "**Contest**") is sponsored by Louisiana-Pacific Corporation (also referred to as LP Building Solutions) ("LP Building Solutions") having a principal place of business at Philips Plaza, 414 Union St #2000, Nashville, TN 37219 (the "**Sponsor**").

**3. Prize Description:** At the conclusion of the Contest, Sponsor will award three (3) Prizes, in accordance with these Official Contest Rules. First place will be awarded \$2,000, second place will be awarded \$1,000 and third place will be awarded \$500.

***a. Entry***

Each Entrant represents and warrants that the photo and caption submitted:

1. (i) Is original and was lawfully produced by the Entrant;
2. (ii) Does not infringe the intellectual property rights or privacy of any third party;
3. (iii) Has not been entered in any other contests or won any awards; and
4. (iv) Does not include content that could be considered obscene or offensive in nature.

All entries must be received by the Sponsor before 11:59 p.m. EST on June 14, 2019. Any entry that is incomplete, late or does not otherwise conform with these Official Contest Rules will be disqualified. Sponsor is not responsible for late or incomplete Entries or for technical problems with any submission. Entrant is solely responsible for all electronic submissions, and Sponsor will not be responsible for any submission that is not received due to an incomplete or improper transmission or other technical problems. Sponsor has no obligation to correspond with any Entrant or acknowledge the receipt of any entry. Sponsor has no obligation to advise Entrant of a disqualified entry, and any entry that is incomplete or does not meet the posted criteria will be disqualified.

***b. Winner Selection.***

Valid entries will be reviewed by the Sponsor. Considerations to select winners include, but are not limited to, proper installation of products, uniqueness of build/design and overall exterior aesthetic appeal. The three (3) Entries selected will win a Prize (“**Prize Winner**”).

Sponsor will notify Winner of the Contest by direct message, email or phone, at the discretion of Sponsor, on or around June 17, 2019. If a Winner fails to comply with these Official Contest Rules, or is ineligible to receive a Prize, the Prize will be awarded to an alternate party with the next highest number of votes in accordance with these Official Contest Rules. The Sponsor shall not be responsible or liable for failure to contact a potential Prize Winner who provides incorrect or incomplete contact information or does not respond within one (1) week from the notification date. Winner may be required to submit valid identification to the Sponsor to claim a Prize.

***c. Award of Prizes.***

Prizes will be awarded within thirty (30) days following verification of eligibility and compliance with the terms of these Official Contest Rules. Prior to receiving a Prize, Winners must sign and return a release of liability form and declaration of eligibility to receive the Prize.
