LP TopNotch Sub-Flooring with SmartGuard technology is designed to withstand warping, splitting, cracking, and inconsistent thickness. The state-of-the-art SmartGuard process includes a zinc borate compound applied throughout the wood that helps protect against fungal decay and termites and superior exterior-grade resins that create an extremely strong product.

In addition to LP TopNotch Sub-Flooring with SmartGuard, Dawn Pacific also used LP TechShield Radiant Barrier Sheathing and LP® SmartSide® Trim & Siding on this project.
